

## **SNOW REMOVAL & DISPOSAL SITES**

In the event we get enough snow that requires removal & the quantity is too much to remain on the property; the Town has designated areas for snow disposal. If employing help with snow clearing, ensure that they know of these sites.

Note that snow cannot be shovelled, blown or scooped onto any public sidewalk, street, boulevard, into drainage ditches, onto culverts, or any property of the Town of Herbert.

- 1) West side of the Sports Complex away from the building
- 2) At the Town's storage pits North side of Connaught Ave.
- 3) West Lift Station (located west of Willoughby St. and Bison Ave.)
- 4) Town's aggregate storage area located North of Connaught Ave.
   & Brownlee St. West side of the road/outside the gate
- 5) Storm field between Klassen St. and Lobethal St. South of Bison Ave.
- 6) North end of Neidpath St. on empty lot in NE corner
- 7) West of The Cube West of the alley by the trees
- 8) North of the former Catholic Church on Shaw St. (500 block)



## **2023 PROPERTY TAX PAYMENTS**

Friday, December 29<sup>th</sup> is the last day to pay property taxes at the town office before interest of 1.87% is applied on January 1<sup>st</sup> of the new year; & each month thereafter, until the levy amount is paid in full.

If paying via online banking, ensure payments are made within 3 - 5 business days prior to December  $31^{st}$  in order for the payment to be reflected in the Town of Herbert's bank account to avoid an interest charge being applied on January  $1^{st}$ .

After April 30<sup>th</sup>, the new tax year process begins & ratepayers can expect the 2024 Tax Notices in the mail by the end of May, or beginning of June.

We strive to provide a public service in the event of an emergency, but if we haven't any way of contacting you via the broadcast system, or social media, important alerts concerning Herbert or specific residents, will be missed. These messages could pertain to boil water advisories, impending or in-progress water/sewer line digs affecting an area of Herbert, etc.
