2025 Property Assessment Notice

This year is a revaluation year for property assessments. The Saskatchewan Management Assessment Agency (SAMA) has finalized the assessments for Herbert for 2025. All property owners will have received a notice in the mail this year, showing both the 2025 assessment and last year's assessment for comparison.

If you have any questions about your assessment, please contact the Town Office for assistance. Please note that appealing an assessment requires a \$250.00 deposit. If your appeal is successful, the deposit will be refunded; however, if unsuccessful, the deposit will remain with the municipality. Appeals should be based on a clear or obvious discrepancy, such as being assessed for a structure (e.g., a garage) that does not exist.

If you believe your assessment is too high, you may first discuss this with SAMA before proceeding with an appeal. The SAMA website contains information on assessment.

SAMA Assessment Basics - by Peter Ryan, Communicatiomns Coordinator - SAMA (Municipal Voice - Summer 2024)

Did you know that the Saskatchewan Assessment Management Agency (SAMA) is responsible for both the assessment system & property assessment services in Saskatchewan?

SAMA performs property inspections through annual maintenance & general re-inspections, revaluations (every four years), & support of value.

SAMA's role in determining assessed property value is just the first part of a process established by provincial legislation. The second part is the application of provincial government established tax policy, such as property classes & percentage of value, & statutory exemptions. The third & final part of the process involves municipalities annually determining the local mill rate based on local budget needs. The province sets the mill rate for the education sector. Municipalities then multiply the taxable assessment by the local mill rate to produce property tax levies. Also known as your property tax bill.
